Rate Information - The interest rate on this account is **4.15 %** with an annual percentage yield of **4.22 %**.

The interest rate(s) and annual percentage yield(s) are accurate as of **05/13/2025**. If you would like more current rate and yield information, please call us at (800) 464-3150. You will be paid this rate until next maturity.

Compounding frequency - Interest will be compounded quarterly.

Crediting frequency - Interest will be credited into this account quarterly.

Effect of closing an account - If you close your account before interest is credited, you will not receive the accrued interest.

Time requirements - This account matures 7 month(s) after account opening.

Callable account - We may call (terminate) this account, at our option with a 30 day notice.

Early withdrawal penalties (a penalty may be imposed for withdrawals before maturity) - The penalty will equal one months interest on the amount withdrawn subject to penalty. In certain circumstances, such as the death or incompetence of an account owner, the law permits, or in some cases requires, the waiver of the early withdrawal penalty. Other exceptions may also apply, for example, if this is part of an IRA or other tax-deferred savings plan.

Withdrawal of interest prior to maturity- The annual percentage yield is based on an assumption that interest will remain in the account until maturity. A withdrawal will reduce earnings.

Automatically renewable account - Your account will automatically renew at maturity. The new term at time of renewal will be 6 months. The new interest rate at renewal will be the same as the rate offered on a 6 month CD. You will have a grace period of ten calendar day(s) after maturity to withdraw the funds without being charged an early withdrawal penalty. You may prevent renewal if you withdraw the funds in the account at maturity (or within the grace period, if any).

Daily balance computation method - Interest is calculated by the daily balance method which applies a daily periodic rate to the balance in the account each day.

Accrual of interest on noncash deposits - Interest will begin to accrue on the business day you deposit noncash items (for example, checks) into your account.

Minimum balance to open - The minimum balance required to open this account is \$1,000.00.

Deposit limitations - After the account is opened, you may not make any deposits.

Withdrawals limitations - You may make withdrawals of the principal from your account before maturity only if we agree at the time you request the withdrawal. Principal and interest withdrawn before maturity is included in the amount subject to early withdrawal penalty. You can only withdraw credited interest before maturity if you make arrangements with us for periodic payments of interest in lieu of crediting.
